- Any change in expenses for 2019 as compared with those reported for 2018
- Any change in the number of household members
- Provide ACRA Credit Report for each parent and the applicant (aged 18 and above) (<https://acra.am>)
- Fill and attach pages 8 and 9 from the Tuition Assistance Application
- Completed Appendix (last page of the application form)

*Application may be submitted after the deadline with the corresponding petition form ONLY IF self and/or the immediate family members had serious health issues which prevented them to submit the complete package within the deadline.*
